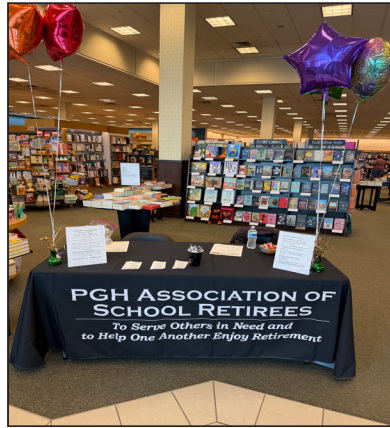
Inside Recess Game Day

Charlotte Fong retired sixteen years ago and since then has dedicated her time and energy to serving the community through volunteer work with more than twenty nonprofit organizations. (PghASR is lucky to be

one of them!) Her volunteer journey began with Meals on Wheels and the Education Partnership, where she found a passion for helping others and supporting programs that improve lives.

Over the years, Charlotte has expanded her service to organizations focused on education, science, environmental stewardship, health, and community well-being. She currently volunteers with the Kamin Science Center, Phipps Conservatory, the Alzheimer’s Association, and Reading Ready, contributing her time to inspire learning, promote healthy communities, and support individuals and families.

Volunteerism has become a meaningful second career, allowing Charlotte to build lasting relationships while giving back to the community that has given so much to her. She believes that every act of service, no matter how small, has the power to make a positive difference. As she looks back on more than 16 years of volunteer service, she is grateful for the opportunity to have touched countless lives while continuing to learn, grow, and make an impact.

Rev. Dr. Terrie Griffin is a native Pittsburgher, and a graduate of Lincoln University and the Virginia Union University School of Theology. Dr. Griffin’s volunteer services involve urban ministry, community outreach and engagement, and social justice. She serves on the pastoral staff of the Wesley Center AME Zion Church



of Pittsburgh, and is a third generation missionary focusing on assisting the homeless or housing insecure. She is the founder of Missions in Motion Urban Ministries. Dr. Griffin and her ministry team of Boots on the Streets (BOTS) distribute meals to the homeless. During the winter months, she and her team of BOTS organize a “Blanket Brigade” delivering blankets, and other lifesaving winter clothing to those living on the streets. Dr. Griffin lives by the words of Dr. Martin Luther King, “the time is right to do the right thing.” It should also be noted that Dr. Griffin’s biography includes extensive work with the League of Women Voters and the United States Commission on Civil Rights.

When James and Denyse spoke with Dr. Griffin about receiving this award from PghASR and PASR, she shared that she does not do what she does for recognition, but rather because of her love for the Lord and God’s people – particularly the “least of these”.

- July 12, 2026. Thanks to the incredible advocacy efforts of our members across Pennsylvania, the **COLA has passed!** This victory would not have been possible without the dedication, persistence, and passion of school retirees who answered the call, contacted legislators, shared their stories, and helped make our voices impossible to ignore. We want to extend our sincere gratitude to every PASR member who participated in our outreach efforts over the past months. Whether you sent an email, made a phone call, attended a meeting, participated in our phone interviews, or spoke with your local legislators, **you made a difference.** This achievement belongs to all of us.

The summary of the COLA language is: Section 1704 -N. Supplemental annuities for public school employees commencing 2026, this section provides for supplemental annuities, also known as cost-of-living adjustments (COLAs), for eligible beneficiaries of the Public School Employees' Retirement System (PSERS) who retired prior to July 2, 2001. These COLAs would commence with the first monthly annuity payment after July 1, 2026, and would amount to increases of between 15 and 24.5 percent of the current annuities of eligible beneficiaries depending on the beneficiary's year of retirement. The increase in the unfunded actuarial accrued liability attributable to the supplemental annuity shall be funded in equal dollar annual installments over a period of 10 years beginning in fiscal year 2027/28 using money allocated under Section 1706-N. The PSERS Board shall not factor this added liability into the setting and accepting of an annual employer contribution rate.

Please take a moment to **thank the legislators in your area** who supported school retirees and helped make this long-awaited COLA a reality. Positive feedback matters, and legislators should know that their support is appreciated. We also encourage you to send a **special thank you** to the two leading champions of our COLA legislation: **Senator Frank Farry and Representative Steve Malagari.** Their leadership, commitment, and unwavering support were instrumental in helping move this legislation forward. Please join us in letting them know how much their efforts mean to Pennsylvania's retired school employees.

While we are celebrating today, our work is never finished. PASR remains committed to protecting and improving the benefits and quality of life of all school retirees. **We will never stop advocating for Pennsylvania's school retirees and the issues that matter most to them.** As always, remember that **PASR is the only association dedicated to representing ALL school retirees—regardless of position.** Whether you served as a teacher, administrator, support professional, or in any other role within our schools, PASR is your voice in Harrisburg. Thank you for your support, your advocacy, and your commitment to our shared mission. MEDICARE SUPPLEMENT REIMBURSEMENT

A. Jay Gross

Just an early reminder if you were a professional employee of the Pittsburgh Public Schools and retired between 1988 and 2008 and are eligible for a Medicare Supplement premium from the Pittsburgh Board of Education, you are reminded that your proof of Medicare Supplement Plan and annual premium payments must be submitted to the Retirement and Employee Insurance Office **no later than February 15th.**

You are eligible for this premium only if you were a professional employee (teacher, counselor, social worker, principal, etc.) who retired between June 1988 and July 1, 2008.

If you get your insurance through HOP, proof of coverage and premium payments can be obtained from the PSERS web site or from the local PSERS office sometime after January 1st.

If you have not yet set up an "Interactive Account" with PSERS to obtain this form (and copies of your 1099 forms), it can be done in only a few minutes by going to : <https://www.psers.pa.gov/> and clicking on the Member Login (MSS) on the right side below the picture of PSERS Headquarters and register for the account. These forms are available under My Documents in the heading selections.

If you get your Medicare Supplemental Insurance from some other source, request a month by month listing of your cost by month for this insurance.

Make Your Life Easier with a PSERS Interaction Account

If you are a retired professional employee of the Pittsburgh Public Schools, who retired between 1988 and 2008, every February you are entitled to receive a reimbursement payment to help cover the cost of your Medicare Supplement Premiums. To receive the payment, you are required to submit a Benefits Statement from HOP/PSERS (or other insurance provider) listing your monthly payments toward your Medicare Supplement Premiums. Every year we are at the mercy of HOP/PSERS to get the Benefits Statement in time to submit it to the Board in order to qualify for reimbursement. Now we no longer have to be at the mercy of HOP/PSERS to get this form. Go to the PSERS website at <http://www.psers.state.pa.us/interaction/default.htm> and set up an INTERACTION ACCOUNT. You will be able to get information and print ALL forms – including the Benefits Statement form and 1099 Tax Form – earlier than you receive them by mail from HOP/PSERS. Do it now and remember it next tax season!

Are you ready for Medicare?

You are nearing 65 and may have wondered what you are going to do regarding your health care insurance as the Board will no longer provide that coverage for you. The good news is that you are now eligible for Medicare and also HOP (Health Options Program) which is provided through PSERS and is designated for retirees and their dependents and survivors' and will now be available for you to get your health insurance Medicare supplemental or Advantage plan though. HOP offers a number of options for medical coverage for which you can choose. Several months prior to your 65th birthday you will receive a packet from HOP. Included in that packet will be the health options that you can select from as well as information about the dates, times and locations for group information meetings. It is always advised that you attend one of these information presentations. If you are still not fully able to make a decision you can request a one-on-one meeting with an advisor at PSERS. Getting your supplemental or Advantage plan through HOP has a number of benefits. HOP provides a \$100 per month premium assistance which is applied to the cost of the plan that you choose. The plans that are available through HOP provide very comprehensive medical coverage and prescription drug plans. The cost of the HOP plans are very competitive with locally available plans and often offer greater coverage at a much better rate. The cost of the HOP plans are automatically deducted from you pension benefits, assuring you uninterrupted coverage. Another benefit is that during the annual selection period an individual may choose to change their plan option without penalty. In addition there is always HOP personnel available to answer your questions about coverage and make recommendations. If you have access to the internet go to the HOP web site at www.hopbenefits.com where you can read more about the coverage through HOP.

The page that opens shows a map of Pennsylvania. Click on the WESTERN 12 area of the map. On the next page you'll see information about Region 12. On the right of that page are two categories, Region 12 Chapters and Chapter Websites. Click on the Pittsburgh link under Chapter Websites to get to the PghASR website.

The second way to access the PghASR website is to go directly to it by typing pghasr.org into the address bar of your browser. You can bookmark it, but if you have the old website address bookmarked, you will have to remove it before you can add the new one.

An important addition to the information on the website is the "Helpful Links" link in the upper left of the website under the PASR logo. Clicking on it will take you to an extensive list of links for organizations important to PghASR members, such as the PASR state website, HOP, PSERS, Medicare, and many others.
